Basis of Union:

The Uniting Church recognises that responsibility for government in the Church belongs to the people of God by virtue of the gifts and tasks which God has laid upon them.

The Assembly shall have determining responsibility in matters of doctrine, worship, government and discipline, including the promotion of the Church's mission, establishment of standards of theological education and the reception of ministers from other denominations, and is empowered to make final decisions on all matters related to the Constitution of the UCA.

Religious Advisory Committee to the Services (UCA representative) Uniting Church Defence Force Chaplaincy Committee (UCDFCC) member

Brief description of the Mandate / Terms of Reference for this body:

UCADFCC provides oversight and discernment for candidates to be nominated as UCA Chaplains to the Defence Force. The RACs member, on behalf of the committee, provides pastoral care for serving Chaplains and their families and assists Defence Force Chaplains in the transitions into and out of Chaplaincy ministry. The UCADFCC promotes the calling to Chaplaincy ministry to the forces when the Uniting Church gathers at events such as Synod and Assembly meetings.

What skills and experience will you bring to the Committee / Task Group/Board?

I have 26 years experience as a Chaplain in the General Reserves. I served on the UCDFCC when it met in Queensland and I have experience on School Boards and served as Moderator of Queensland (2011-2014.) In that role I represented the Uniting Church in Heads of Churches meetings, in various public forums, chaired Synod meetings and served on the Uniting Care Board. I have been involved with the discipline processes of the Church and through Presbytery life I have been engaged in the recruitment, formation and ordination of candidates for ministry. I have served in the life of Presbyteries on Pastoral Relations Committee and as Presbytery Minister giving me experience in the pastoral care of ministry agents and their families. My skills are in preaching, teaching, pastoral care, governance and leadership

What if any relevant experience have you had in the life of the Church?

I was ordained in 1984, 40 years ago and I have served in various congregational placements as an ordained minister and two years in School Chaplaincy. Since 1992 I have also served in a parallel career and calling as a part-time Chaplain in the Army. My most recent posting prior to discharge from Defence was to The Australian Army Cadets HQ in Brisbane. I have attended the Assembly meeting four times.

What if any relevant qualifications do you have?

My initial training and formation for ministry happened 1981-1983 at Trinity Theological College in Brisbane. I have trained as an Army Chaplain through the channels required by the Australian Defence Force
